



Northern Chapter Professionals:

Welcome to the **2012 Northern Chapter Tournament Series**. We are very excited about this year's tournament schedule and we are once again pleased to say that the professional entry fees for 2012 Northern Chapter Tournament Series will not increase yet the number of events has, making for a better value than ever. The 2012 Northern Chapter Tournament Series is one you cannot help but get excited about! Your amateur partners will really enjoy starting the year with the traditional kick-off at the King and Bear Pro Am at the World Golf Village. They can also expect to play such great facilities as Amelia National, Deerwood Country Club, Lake City Country Club, Long Point Country Club, Marsh Creek Country Club, Ponte Vedra Ocean Course, San Jose Country Club, Sawgrass Country Club, The Golf Club at South Hampton, The Palencia Club, TPC Sawgrass, Windy Harbor, and new to the tournament trail a road trip to Capital City Club and Southwood Golf Club in a two day tournament. Finally, at the end of the year Tournament of Champions (2007-Present Champions) will square-off to determine the best of the best in the Tournament of Champions. We will continue to have new formats and fun events for 2012. At times PGA Member priority may be used when events demand it.

We have again included two options for our Chapter Professionals to participate in the 2012 Northern Chapter Tournament Series. Either the Facility Membership or Tournament Membership Series, allow for PGA Members/Apprentices to save throughout the year with the pre-paid options including all Pro-Ams, Pro/Pro tournaments, and Chapter Majors. The Facility Membership is \$300 and allows the facility to pay one fee, but retain the option to send different professionals to each event. Should a facility wish to send two professionals to each Pro-Am or Chapter Tournament, the Facility Membership will be \$500.00. Any additional Facility Memberships will be \$100.00 per PGA Member or Apprentice. Members of the 2012 Northern Chapter Tournament Series will receive discount benefits to the Chapter Majors and Chapter Pro / Pro events plus have an even better financial savings through our new "Majors Package." Facility Memberships are available for purchase prior to January 23, 2012.

Individual Tournament Membership Series fees for those Professionals unable to participate in a Facility Membership will be \$300.00 until January 23, 2012. After January 23rd, the fee will raise \$100 for the remainder of the year. Professionals that purchase the 2012 Tournament Series membership fee will receive discount benefits to the Chapter majors and Chapter Pro / Pro events. If you are not a member of the Tournament Membership Series, the professionals entry for all Pro Am's will be \$100.00 per event and an additional \$100 for chapter major events from the member entry fee. **This is a savings of up to \$1,500.**

New for 2012 – Tournament Membership Series or Facility Membership professionals will have an opportunity to purchase the "MAJORS PACKAGE." The Majors Package will include reduced pricing when members submit complete entry fees for all Major events prior to March 1, 2012. This pre-paid fee will be \$300.00 and allow for PGA Members to receive one entry to all Chapter Majors including the Chapter Championships, Match Play Championship, Chapter Shootout and the Chapter Stableford. **This is a savings of \$450.**

Special thanks go out to our Northern Chapter host professionals for supporting the **2012 Northern Chapter Tournament Series** and making it one of the best in the Section. We realize each facility and professional makes a choice to host an event and we greatly appreciate their support. Your Board will continue to work hard to make this year's events as enjoyable and competitive as possible.

Items of Interest for 2012 Tournament Series

- Male Professionals will play from the same set of tees as their amateur partners in the 2012 Pro Ams (with the exception that women amateurs playing with male Professionals will play from their respective tee box) from distances 6400 – 6600 yards.
- Women Professionals will play from distances (by hole) 85% of the yardage set up for male Professionals.
- Senior male amateurs (60 years of age or older) will have the choice to move forward one tee with handicaps adjusted accordingly based on USGA Recommendations.
- Super-Senior male amateurs 75 and older will have a choice to move forward two tees with handicaps adjusted accordingly based on USGA Recommendations.
- The Chapter Championship will consist of a 36-hole stroke play competition. The 2012 Chapter Championship will also consist of two separate events, the Chapter Championship and the Senior Chapter Championships will be played on different dates.
- Points will be awarded toward the Chapter Player of the Year Award for Chapter events through the November Pro-Am.
- Points will be awarded toward the Porter Cup (Formerly known as the Chapter Challenge Cup) team through the October Pro-Am.
- Players *must* sign up for all events through the on-line registrations prior to the event deadline.
- There will be a separate points list and Player of the Year award for our top juniors and seniors, plus a Cup Point Standing.
- We will require golf professionals to post their amateurs pro am tournament scores.
- Points for professional of the year will be split in case of ties with the exception of first place (if three players finish tied for second place; 2nd, 3rd, and 4th place points will be split and equally distributed to all players in the tie. The next place will receive 5th place points).
- Section points will be received based on entire field finish, not just chapter participants.
- Amateur fees for 2012 Pro Am events will be raised from \$85.00 to \$95.00 to allow for growth. Changes to our tournament costs have not increased in over 10 years. The ten extra dollar increase will be used to increase the team purse and food and beverage.
